OUR ANTI-LIGATURE LOAD RELEASE FITTINGS


To restore dignity and create a homely environment, vulnerable patients need fixtures and fittings that are familiar and, most importantly, safe.

Existing products failed to address this issue, so we developed a range of load release bedroom and bathroom fittings that are anti-ligature and lightweight, yet durable. The results keep staff and patients safer and facilitate a recovery-led environment.

HOW LOAD RELEASE WORKS

The release mechanism uses a spring hidden inside the anti-tamper casing. It provides a robust connection that only releases when needed – a simple concept that really works.

OPERATION


The anti-ligature bracket is fixed to the wall or ceiling. When an abnormal load is applied, the lightweight fitting is released, with the components pushing back together afterwards.



The anti-tamper casing conceals the release mechanism




When downward load is applied, the fitting safely detaches without causing any damage



The fitting is then pushed back together, ready to be used again




MAGNETIC

Magnetic anti-ligature systems answer many of today's requirements. But as they're only kept intact by magnets, they can often become detached accidentally due to their multi-directional load release, causing frustration. The most common example is curtains detaching completely when being pulled open or shut.

Because such fittings rely on a perfect magnetic connection, side bracing is often fitted to prevent detachment.


The magnets in the fittings can make the product heavy – curtains in particular – meaning they make an effective weapon when detached.



PLASTIC

When deliberately damaged, plastic-based components leave very sharp edges which can be used to self-harm. Plus some fittings use plastic components that shear to reduce ligature risk – needing replaced after each incident, adding to maintenance costs.

BENEFITS OF OUR LOAD RELEASE SYSTEM



MINIMISES ACCIDENTAL DETACHMENT

Our clever design ensures the fitting is **only released under a downward load**. This minimises accidental detachments, making life easier for staff and patients and extending the fitting's lifespan.



LIGHTWEIGHT AND SAFE

The fitting's detachable parts are lightweight and make an ineffective weapon, **minimising the risk to staff**.



FIRE RESISTANT


A special chemical is used to stop the mouldings burning within ten seconds, minimising the risk of vandalism and wider damage.



ANTI-LIGATURE AND SHATTER-RESISTANT

Built from **strong, high-performance ABS plastic**, the fittings won't shatter into jagged pieces, reducing the risk of self-harm. Plus it's hard-wearing, offering a **long-term solution**.

And like all Safehinge Primera products, it's been thoroughly tested to the DHF TS001 specification – in our workshop and independently by Exova.



SIMPLE AND DISCREET

Clean, simple and discreet, our fittings are white with a highlighted colour ring, to coordinate them with existing decor.

Please note: The final letter of the product code (A, B, C, D) refers to the colour ring. Some fittings are available in just white.

The rail material varies between fittings and is noted, where applicable, before the colour ring as follows: chrome (X), white (Y) or polycarbonate (Z).

Customers often tell us how important creating a homely environment is to recovery. That's why providing safe bathroom fixtures and fittings that also look the part is key to establishing the right atmosphere.

Traditional anti-ligature fittings may be safe, but can look sanitised and out of line with modern approaches to recovery. They clearly indicate a different, more institutional environment – and removing them altogether implies that the patient can't be trusted.

That's why we developed a range of safe fittings that look just like the ones you'd find in a **home bathroom** – restoring **dignity**, creating a sense of **normality** and aiding **recovery**.

INDEPENDENTLY ANTI-LIGATURE TESTED

We carefully balance practicality and normality with safety in everything we do. That's why all our fittings are tested to the Door & Hardware Federation Technical specification TS001, which tests resistance to ligature attachment.

The fittings were tested with a 0.5mm wire diameter and a 10kg downward load – passing at the highest level.










VANITY SHELF STRAIGHT



Our curtain tracks keep patients safer, protect privacy and reduce maintenance problems. Using them for window curtains helps create a homely environment by blocking light and minimising echoes.


Our tracks are designed for **practical day-to-day** use, so staff and patients can draw them quickly and easily. Plus they won't detach if pulled sideways, eliminating any accidental detachment. Any abnormal vertical load over 10kg (per fixing) will immediately release the track, preventing damage to walls and ceilings and **keeping patients safe**.

Made from shatter-resistant materials, the tracks can easily be pushed back together after detachment, reducing repair costs and saving time.

Avon and Wiltshire Mental Health Partnership NHS Trust provide care for dementia sufferers, relying on bed curtains for privacy in shared wards. Having tried magnetic track systems, they found that the curtain track detached even in normal use, causing frustration and disruption. Our load release system eliminated the problem, with only the curtain track coming free, leaving the down-poles attached the the ceiling – making it easier for staff to reattach. The down-poles are also designed to detach separately if they were used to self-harm.







TECHNICAL AND SPECIFICATION INFORMATION

In the absence of formal British Standards for anti-ligature products, the Door & Hardware Federation has drawn up a method of classifying fixed and load-release devices. This specification – TS001 – has been adopted for independent ligature risk assessment.

We use this specification to **independently test** and classify our anti-ligature hardware, with all our **products passing at the highest level** in their respective categories. Testing is **rigorous**, **measurable** and **repeatable** – so it's a reliable part of your product assessment process.

The result is **total compliance** and products which reduce the risk of self-harm, without sacrificing durability or aesthetics.
